Rose Festival Parade Celebrates "Greatest Generation"

Portland Rose Festival brings fun and entertainment of all types to the Portland area, and this year was no exception as the annual event was held on Saturday, June 9.

Each year the Grand Floral Parade becomes the centerpiece of the Rose Festival and this year the all-floral float entries paid tribute to Rose Festival history, incorporating recreations of some of the best floats of the last century. Since 1907, this internationally distinguished parade has been recognized as one of the top five parades in the nation.

In honoring its history, the parade celebrated both past and present generations, among them, *The Greatest Generation*. This generation celebrates the war time years. Patriotic fervor enveloped the throngs of parade goers with a recreation of a World War II era Victory Parade. Pride swelled in the hearts of many as veterans and active-duty servicemembers from several branches and eras of the Armed Forces from WWII to the present day marched through the streets of Portland!

The Royal Rosarians hosted a float for the Wartime Rose Festival Princesses from 1942-1945, who were unable to ride in a parade at that time due to a ban on large public gatherings based on the threat of attack. Spectators were especially excited as a WWII-era tank rumbled down the parade route.



The "Riderless Horse," Pistol, passes down the parade route. The horse is a symbol of those service men and women who will "ride no more." Pistol carried a scroll listing the 3,397 names of the Oregonians who have died in foreign wars over the past century.

As the battalion of past and present servicemembers marched through the streets, there were many reminiscent and melancholy moments as veterans and spectators alike recalled the days when these heroes came home. Many a tear was surely shed in remembrance of those who will never come home.

The parade began at the Portland Memorial Coliseum and traveled down Martin Luther King Jr. Blvd. before crossing the Willamette River and heading for downtown Portland. The route concluded near Civic Stadium after winding through downtown Portland.

Inaugural Military Gala Held in Salem

The 1st Oregon All Military Gala was held in the capital city on Saturday, June 16. Director Jim Willis of the Oregon Department of Veterans' Affairs served as the Master of Ceremonies for the event that hosted hundreds of guests from across the state and nation. Terry Williams of the Marine Corps League praised the event as a "smashing success" and was ready to begin planning for 2008 as "Oregon's Own" 234th U.S. Army band struck up the party.

Staff Sergeant Christian Bagge flew in from Texas to deliver an inspirational keynote speech. Bagge, a former Oregon National Guardsman brought to life his personal story of war and triumph over giving his legs in battle after an attack on his Humvee. He spoke of his first thoughts after the attack, while clearly describing his request to tie his wedding band to his wrist. Bagge is now involved in building a memorial in Washington, D.C. with the Disabled Veterans Life Memorial Foundation.

After Bagge completed his speech, he was met with a handshake from World War II veteran and Medal of Honor recipient George Sakato. Sakato and his daughter flew in from

A brochure is being produced to explain how these choices will be made. One of the best features of this new program will be that there will only need to be 500 total renewals of all the various kinds of veterans' plate to ensure the program will continue year to year.

I want to thank the Rose Festival Association for including a salute to our state's veterans as part of this year's Grand Floral parade. The honor paid to veterans is much appreciated and especially the tribute to the Greatest Generation.

In closing, I want to wish our great country a very happy 231st birthday! I hope you will be able to attend some of the many events around our state that honor our country on the 4th of July. Thank you also for your continued support of the Oregon Veterans' Home in The Dalles.

If you have not had the opportunity to visit our Home, please plan to do so when your travels take you to The Dalles. I hope all of you are having a safe and healthy summer and enjoying some time off with friends and family.

Three New Veteran Medical Clinics for Oregon

A new U.S. Department of Veterans Affairs (VA) medical clinic has opened in East Portland. The clinic is located at 10535 NE Glisan Street in the Gateway Medical Building on the 2nd Floor. The clinic can be reached at 503-220-8262.

The VA announced on May 29th that 38 new veteran clinics will soon open across the nation. The new facilities, called community-based outpatient clinics, or CBOCs, are slated to be operational by October 2008. Dr. James Tuchschmidt of the Portland VAMC recently announced a 20,000 square foot clinic will open in Washington County. The VA is still scouting areas for construction.

Officials at the Johnathan M. Wainwright Memorial VA Medical Center in Walla Walla Wash., announced a decision from the VA Central Office for the location of a clinic in La Grande.

Local VA officials will continue to provide updates on the creation of the new CBOCs. For assistance in enrollment, contact the nearest Veterans' Service Officer listed on page 12.

New VA Loan Program Interface

The U.S. Department of Veterans Affairs (VA) recently completed a project to redesign all loan servicing regulations, processes, and reporting requirements. The new regulatory environment is being implemented through process changes, organizational changes, and a new application service. The new application service is called the VA Loan Electronic Reporting Interface (VALERI) replaces the current loan servicing system.

VALERI is slated for implementation beginning in November of this year with Wells Fargo Home Mortgage Inc. Implementation is scheduled for completion by August of 2008. VA will continue publishing implementation information on the VALERI website online at http://homeloans.va.gov/valeri.htm. The ODVA home loan website is online at www.oregon.gov/ODVA/loans.shtm.

VA Moves to Strengthen Suicide Prevention

The Department of Veterans Affairs (VA) has announced plans to hire suicide prevention counselors at each of its 153 medical centers.

VA will be reviewing all of the Department's programs to care for the mental health needs of veterans, especially those returning from combat in Iraq and Afghanistan. In May, VA announced an initiative to hire 100 new employees to provide readjustment counseling at each of the Department's 207 community-based Vets Centers.

The Secretary of Veterans Affairs Jim Nicholson said, "Every suicide is a tragedy that sends ripples of pain throughout families and communities. VA health care professionals are committed to provide timely, compassionate intervention, which might help prevent this needless suffering."

The Department spends nearly \$3 billion a year for mental health services to care for about 1 million VA patients with a mental health diagnosis.

Vietnam Memorial to Celebrate 25 Years

Twenty-five years after its dedication, the Vietnam War Memorial in Washington, D.C. will host events over Veterans' Day weekend, November 7-11, and celebrate a quarter-century of being a healing place for veterans and their families.

Beginning on November 7, approximately 2,000 volunteers will read the 58,256 names inscribed on the Wall. The reading of names will take place for 65 hours over a four-day period. This will mark the fourth time in The Wall's history that all of the names have been read aloud in Washington, D.C.

The Memorial stands as a symbol of America's honor and recognition of the men and women who served and those that sacrificed their lives in the Vietnam War. The memorial remains the most visited in the nation's capital with more than 4 million visitors annually.

On April 27, the names of three more American servicemen were inscribed on the walls of the Memorial as their deaths were found by the Department of Defense to have been directly related to the war. Another 14 servicemembers received status changes.



A Memorial Center, which is slated to open in 2010, will be an underground facility with displays relating the Memorial's history and a timeline of the war. Another planned exhibit will feature some of the 100,000 items left at The Wall—a unique legacy for current and future generations to contemplate.

VA Medical Centers Extending Hours

In order to provide more health care for more veterans, especially mental health services, Secretary of Veterans Affairs Jim Nicholson has directed the 153 medical centers of the Department of Veterans Affairs (VA) to keep their doors open longer.

"Illness doesn't follow a 9-to-5 schedule," Nicholson said. "I'm directing our medical centers to provide extended hours to ensure we're there for the veterans who have earned our care."

Although the extra hours apply to many hospital-based programs and services, Nicholson said his latest decision was based upon a desire to ensure VA's more than 9,000 mental health professionals are available when veterans need them.

VA operates the largest integrated health care system in the country and the nation's largest mental health program. About 5.5 million veterans are expected to seek health care from VA's nationwide system this year, accounting for about 800,000 hospitalizations and 60 million outpatient visits.

VA's mental health experts will gather in Washington in July for a four-day conference reassessing the Department's programs for veterans, especially veterans from the conflict in Iraq and Afghanistan.

At this time, the details as to which facilities the extended hours will impact and what the hours will be has not yet been established.

Afghan - Iraqi Freedom Memorial Adds Names of Fallen

It was a day of contrasts.

The forecast for May 28 was for sunny skies, but as the morning sun gave way to overcast skies and a chilly breeze, the forecast seemed wrong. Then around noon, the skies



cleared, the sun came through and the gentle breeze felt much warmer.

It was about this same time that the steady stream of motorcycles and riders descended upon the grounds. The roaring of the bikes were a stark contrast to the solemn peace and reverence that the Afghan Iraqi Freedom Memorial offers, and that which would follow in the 1 p.m. ceremony.

Even the purpose of the event had contrasts. It was both a celebration of the lives of those servicemembers who have died in the current conflicts, and a solemn time of mourning and sadness as many Gold Star families were in attendance to honor their loved ones who have been lost.

There was young and old alike in attendance, as bikers stood shoulder to shoulder with bankers and grandmothers who could grace the cover of the Saturday Evening Post. But of all of those attending, it was the Gold Star families, those who have lost a family member in military conflict, who were both honored and were there to honor their loved ones.

The ceremony began with the Grand Ronde Honor Guard posting the Colors and former Miss Oregon, Heidi Rickey singing the National Anthem as a Blackhawk helicopter from the 1042nd Medical Evacuation Company of the Oregon Army National Guard provided a flyover.

ODVA Deputy Director, Paula Brown offered opening remarks while Chaplain Col. (Ret.) Rich Meyers gave the invocation,

benediction and the official laying of the wreath.

A Gold Star father himself, whose son Erik was killed in Iraq in 2004, Col. (Ret.) Scott H. McCrae served as the Keynote Speaker, while an echoing version of *TAPS* was played by Dave, Hanna and Bryce Schmidt.

The centerpiece to the ceremony was the unveiling and reading of the names of the servicemembers who have been lost since the memorial was first dedicated on Veterans' Day in November of 2006.



In Memoriam Dale S. Albee

July 13, 1919 – May 14, 2007



On May 14, Oregon lost a premier veterans' advocate with the passing of Dale Albee of Prospect, Oregon.

Dale served in the United States Army from 1938 until his retirement in 1960. He was very proud of having been in the US Army Cavalry prior to WWII and the stories of his life in the "horse" Cavalry are legion.

One such story involved Dale's response to a reporter who asked what happened when one was bucked off his horse. With his usual sense of humor, Dale replied that "Horses are herd animals, and if you are bucked off, you can count on them rejoining other horses or going to their daily food source – leaving you, the rider, with a long walk back to camp."

During WWII, Dale served with the Armored Cavalry as a tank commander. He was one of 12 sergeants in his outfit to receive a battlefield commission and at the time of his retirement, had achieved the rank of Major.

Dale's military decorations included a Bronze Star with V, two awards of the Purple Heart medal and the European-African-Middle Easter Campaign Medal with five Battle Stars.

Following his retirement from the Army, Dale made it his business to look after his fellow veterans. As a volunteer, he worked at the VA Hospital in Portland and in later years at the VA Hospital in Roseburg and the Clinics and Rehabilitation Center in White City.

Dale also served eight years on the Governor's Advisory Committee to the Director of the Oregon Department of Veterans Affairs including two terms as Committee Chair.

His can-do attitude was infectious and drew people to him to join in his service to fellow veterans. He was a longtime member of the VFW and a member of Chapter 147 of the Military Order of the Purple Heart where he served as the State Adjutant for many years.

Dale Albee set a standard of service to fellow veterans that is a benchmark for anyone who would call themselves an advocate. Well-done, Dale. Rest in peace.

Two Oregon WWII Vets Presented the French Legion of Honor Medal by French Government

More than 60 years after the Allied forces in Europe liberated France from the Nazi regime, two Oregon World War II veterans have been presented France's highest honor for bravery. The French government approved the presentation of the Legion of Honor (Legion d'Honneur) to Portland area veterans John Hodges, 87, and Robert Weiss, 84, for their service during the battle to liberate France from the German Army in 1944-45.

Before a gathering of family and friends, both men received their awards on two separate occasions. The Deputy Consul General, Patrice Servantie, from the French Embassy in San Francisco, presented Hodges his medal on February 22. Hodges said, "I'm most honored to receive this, but I'm accepting it on behalf of my buddies who can't be here."

Hodges' unit, the 616th Ordinance Ammunitions Company, 5th Engineer Brigade, played a vital role in establishing the first ammunition supply facilities on Omaha Beach, Cherbourg, France and at Leige, Belgium.

Weiss received his medal from Consul General Frédéric Desagneaux on March 17. He served in the 230th Field Artillery Battalion of the 30th Infantry Division in France. "One thing I learned from that battle is that determined men can make a difference in the lives of others," Weiss said.

Both Desagneaux and Servantie said it was their personal honor to present France's highest military medal given for "exceptional merit or bravery and for outstanding military accomplishments to the State."

Retired Marine Officer Receives Medal of Honor from National Society of the Daughters of the American Revolution (DAR)

In late 2006, members of the Anna Maria Pittman Chapter of the National Society Daughters of the American Revolution (NSDAR) presented Lt. Col (ret.) Herman A. MacDonald for nomination for the NSDAR Medal of Honor and the Historic Preservation Award.

Earlier this spring, MacDonald was awarded the NSDAR Medal of Honor. The award is for Adult Native-born American citizens who have displayed Leadership, Trustworthiness, Service and Patriotism. MacDonald also has recently received the NSDAR Historic Preservation Award for collecting, categorizing, authenticating, preserving, and displaying military uniforms.

MacDonald retired from the U.S. Marine
Corps after twenty-five years of service. A
combat veteran of the Korean War,
MacDonald went on to become the
Commanding Officer of Force
Reconnaissance at Camp Pendleton. He
served during the Vietnam War, taking part in
Marine Reconnaissance and assignments with
the Navy SEALS and Green Berets.
MacDonald also served at Marine

Headquarters in Washington, D.C. and finished his career with 24 ribbons including Presidential Unit Citations from the U.S. Army and U.S. Marines.

After thirty years of service to his country, he retired in 1978. Continuing his passion for service, MacDonald entered into Salem-Keizer School District to become a schoolteacher. Soon thereafter, he was appointed the principal of the Woodburn

Gervais Alternative High School. After his retirement there, he continued on with public service as a lobbyist for Oregon veterans.

The Daughters of the American Revolution dates back to the late eighteen hundreds and is headquartered in Washington D.C. and has honored and aided veterans since the birth of the organization. The members of NSDAR is comprised of adult women with lineal descents to patriots of the American Revolution.

Historically speaking, NSDAR has been taking care of veterans since the Spanish-American war. Dr. Anita Newcomb McGee, the founder of the Army Nurse Corps is responsible for setting up the Hospital Corps. Aid and Attendance Benefits

The Oregon Department of Veterans' Affairs (ODVA) works hard to ensure that veterans receive all the benefits they have earned as a result of military service. One of the ODVA veterans' service officers tasks is to obtain Aid and Attendance (A&A) benefits for veterans and their families.

Veterans, their spouses, or surviving spouses are eligible for A&A if they are receiving compensation or pension, and require the regular attendance of another person to assist in daily activities, such as eating, bathing, dressing, or using the restroom. Compensation and pension include Dependency and Indemnity Compensation, and death pension for surviving spouses.

A&A does not provide in-home care workers, but provides the recipient an extra amount of money to help offset the cost of in-home care.

Because A&A is an added benefit, the applicant must first be receiving compensation

or pension. However, initial applications for either compensation or pension can include a request for A&A if the claimant meets the physical requirements.

When applying for A&A, the federal VA will require the claimant to have their physician complete a report describing the condition of the claimant. This is to ensure that the claimant meets the physical need for A&A.

A&A can provide up to \$1,519 per month to a veteran; \$976 per month to a surviving spouse; or \$1,801 per month to a couple. This amount is in addition to the regular compensation or pension the VA is paying to the recipient.

If you believe you or your spouse qualifies for Aid and Attendance, be sure to schedule an appointment with your local veteran service officer to discuss applying for A&A.

Free Legal Services Offered For Servicemembers and Their Families

In 2003, in recognition of the several thousand members of the Oregon National Guard, and Army, Navy, Marine, and Air Force service members from Oregon who are now serving in Iraq, Afghanistan, and elsewhere, the Oregon State Bar has established a Military Assistance Panel to provide free legal services to service members and their families. The panel will assist on issues relating to the Servicemembers' Civil Relief Act, and the related areas of family law, residential landlord/tenant, and debtor/creditor issues.

The bar is hoping that by donating some of its members' time and talent, it might in some small way alleviate the burden for the state's service members. Servicemembers seeking panel assistance should contact the bar's Lawyer Referral Service at 800-452-7636.

The greatest requirement of service members and their families are in the area of family law. The strains of military service, coupled with the financial losses of active duty, put a tremendous strain on military families. About half of all requests for panel assistance are for family law practitioners. This need is particularly great in many of the state's rural areas.

The only obligation for panel participation is to provide a couple of hours of advice upon referral from bar staff (although in most situations, panel members undertake full representation, to resolve the problem at hand without charge).

Attorneys who join the panel are provided a free, two-credit continuing legal education program on the SCRA and on the related of family law, residential landlord/tenant, and

debtor/creditor issues. The CLE may be taken by either DVD or streaming video.

The panel is open to all lawyers, including those who are not in active private practice and otherwise do not have Professional Liability Fund coverage. For such lawyers, PLF coverage is provided through a special umbrella policy for bar certified *pro bono* programs.

Oregon Legislative Assembly Winds Down

As the 74th Legislative Assembly winds down there are some Bills still pending action and others that await the Governor's signature. There have been some Bills passed already this session that impact veterans or their families.

As of the date of our submitting this issue of *VETS NEWS* to the printer, below is an overview on the status of various legislative Bills that we feel would be of interest to veterans and their families.

Senate Concurrent Resolution 7 – Filed with the Secretary of State on May 22, 2007.

Recognizes and honors sacrifices that employers make in support of employees who are members of Oregon National Guard and reserves.

Senate Joint Resolution 23 – Filed with Secretary of State on May 22, 2007.

Designates Sunday before Veterans Day as annual Blue Star Memorial Highway Day.

Senate Bill 590 – Has passed both the House and the Senate and will be presented to the Governor for his signature.

Expands crime of criminal impersonation to include impersonation of active member or veteran of the Armed Forces.

Senate Bill 822 – Has passed both the House and the Senate and will be presented to the Governor for his signature.

Requires public employer to provide preference to veteran or disabled veteran if veteran's score on evaluation or civil test is equal to or higher than the score or evaluation of person who is not a veteran or disabled veteran. Also, allows veteran to use preference more than once. Brings Oregon's veteran preference policy for public employment in line with the federal policy.

Senate Bill 859 – Has passed both the House and the Senate and will be presented to the Governor for his signature.

Expands the number of entities that must be printed on Oregon income tax return forms for charitable donations by refund check-off. Requires that all Charitable Check-off entities rotate between the form and the roster or instruction booklet.

Senate Bill 5541 – Governor signed on May 15, 2007.

Appropriates money from state's General Fund to Department of Veterans' Affairs for biennial expenses. (ODVA 2007-09 budget)

House Bill 2157 – Governor signed on April 17, 2007.

Adds unremarried surviving spouse of veteran to those persons who are eligible to receive funds from the existing Emergency Financial Assistance program through the Oregon Department of Veterans' Affairs.

House Bill 2237 – Has passed both the House and the Senate and will be presented to the Governor for his signature.

Eliminates annual claim filing requirement for veteran homestead property tax exemption, if exemption has been allowed in previous year and the ownership, use and other qualifying conditions remain unchanged. Continues annual filing requirement if basis for exemption includes satisfying maximum total gross income ceiling.

House Bill 2390 – Governor signed on June 11, 2007.

Directs the Department of Transportation to create registration plate recognizing recipients of the Medal of Honor.

House Bill 2447 – Governor signed on April 27, 2007.

Declares January 13 of each year to be Korean American Day. Establishes Korean American Day Commission to promote, organize and coordinate Korean American Day celebrations.

House Bill 2630 – Governor signed on May 31, 2007.

Permits state employee or state officer to authorize deduction from their salary to go to the Oregon Veterans' Home Account.

House Bill 2937 – Governor signed June 12, 2007.

Directs the Department of Veterans' Affairs to provide veterans and health care providers with educational materials on diagnosis, treatment and prevention of hepatitis C.

House Bill 3009 - Has passed both the House and the Senate and will be presented to the Governor for his signature.

Permits a second state Oregon Veterans' Home to admit spouses of war veterans. Eliminates requirement for second Oregon Veterans' Home to obtain certificate of need from Department of Human Services. **House Bill 3161** - Has passed both the House and the Senate and will be presented to the Governor for his signature.

Directs the Department of Transportation to establish a program to issue veterans' recognition registration plate to veteran or veterans' group and the Gold Star Family recognition registration plate.

House Joint Memorial 19 - Filed with Secretary of State on June 5, 2007.

Urging Congress to fund transportation of, and United States Department of Defense to transport, comfort items to troops overseas and request that priority be given in directing health care and benefits for veterans..

House Joint Resolution 7 – Filed with the Secretary of State on April 9, 2007.

Designates December 13 of every year as "Honor Our Oregon National Guard Day" and urges all Oregonians to commemorate this day in appreciation of the Oregon Guard.

House Joint Resolution 12 – Filed with Secretary of State on May 10, 2007.

Encourages Oregonians to join in celebration of Korean American Day.

NOTE: At presstime, the legislative body had indicated their intention to complete this session by the end of June. Once the session concludes, there will be a complete listing of the Bills that affect or may interest veterans that were passed in the September-October issue of VETS NEWS.


